Notice is hereby given, that on Tuesday, the 5th day of November, 2024 at the polling places in the election precincts of Jefferson County Nebraska an election will be held. The polls will open at 8:00 a.m. and close at 8:00 p.m. Said election will be for electing candidates to various offices. Voters living in school districts that cross county lines will be voting on candidates and special issues in their respective districts. Proposed Amendments to the Constitution and Initiatives or Referendums will be published by the office of the Secretary of State, once a week for three consecutive weeks prior to the General Election.
