

NOTICE OF ELECTION

I, Kristina K. Riggle, Jefferson County Clerk, Fairbury, Nebraska do hereby certify that the names of the persons appearing on the ballots are qualified electors of the State of Nebraska and the County of Jefferson and have made personal filings or accepted petitions filed in their behalf. Each candidate has met the statutory filing deadline and other requirements of law.

I further certify that each candidate is entitled to have his or her name printed on the official ballot, to be used in the primary election as candidates for nomination on the party ticket or as a non-partisan candidate as indicated on the ballot.

County Commissioner Dist. 3, County Assessor, County Attorney, County Clerk, County Sheriff, County Treasurer, County Surveyor, Southeast Community College Dist. 1, Little Blue NRD Sub 8 (2 yr term, 4 yr term & at Large), Lower Big Blue NRD Sub 2 (4 yr term & at large), Nebraska Public Power

Dist Sub 7, Norris Public Power Dist West Sub, School Districts 8, 100, 300, Fairbury City Council Ward 1, 2, 3, 4, and Airport Authority races will not appear on the Primary Election as the number of candidates filing for office did not exceed twice the number of vacancies; these candidates are declared nominated and will advance to the General Election. Please be advised this is a SAMPLE BALLOT and because the law requires rotation of the candidates' names, the order as listed may be different in your precinct. Some listed candidates are elected in SPECIFIC DISTRICTS; therefore, not all contests appear on all ballots. All ballots have been cut down from their 8 1/2 x 14 size to save on publication costs.

Non-partisan voters requesting a Non-Partisan Democrat or Libertarian ballot will vote on all races as if they were a member of that specific party.

Polls will be open 8 A.M. TO 8 P.M. on Tuesday, May 12, 2026.
