<b>Conditional Use (CUP)/Special Use Permits (SUP)</b> (With public hearing) (All districts)	\$250.00	Including livestock *CAFO over 301**AU. Zoning Permit may be required after approval
<b>Application to Board of Adjustment (Variance)</b>	\$100.00	Appeals
<b>Zoning District Change</b>	\$100.00	
<b>Subdivision Lot Platting</b>	\$200.00	Creating multiple lots. Residential.
<b>Administrative Subdivision (land subdividing)</b>	\$50.00	Subdividing Land 10 acres or less. Survey required. Applicant responsible for recording.
<b>Wind Towers-Commercial</b> Commercial Wind Energy Conversion System (CWECS)	\$250.00 \$100.00 -----  \$50.00	CUP for wind farm and MET towers is required. Per megawatt of nameplate capacity on towers. Applicant is also responsible for all fees associated with the commercial application process. (certified mailings, paper meeting notices, etc.) Zoning Permit for each tower and other structures
<b>Wind Towers-Use on same parcel</b> Small Wind Energy Conversion system (SWECS)	\$250.00 \$50.00	CUP is required. Plus, Zoning permit
<b>Solar Residential</b> Small Residential 0 to 25kW	\$50.00	Zoning Permit only. No CUP, No Fees
<b>Solar Commercial</b> Small Commercial 26-100kW Large Commercial 101kW-1mW Large Commercial 1mW-100mW Large Commercial >100mW	\$250.00 \$100.00 -----  \$50.00	CUP for solar farm is required. Per megawatt of nameplate capacity of solar farm. Applicant is also responsible for all fees associated with the commercial application process. (certified mailings, paper meeting notices, etc.)  Plus-Zoning permit for solar farm. Buildings will need a separate Zoning Permit.
<b>Floodplain Development Permit</b>	\$0.00	
<b>Wireless Towers</b>	\$250.00 -----  \$50.00	CUP is required. Applicant is also responsible for all fees associated with the commercial application process. (certified mailings, paper meeting notices, etc.) Zoning Permit for tower
<b>Wireless Tower upgrade or equipment added to current tower/or in building.</b>	\$0.00	If not increasing height and/or footprint.
<b>Permits - Late Fees</b> Improvement(s) without permit. Including *CAFO moving to next *AU. Level.	4x permit fee -----	Four times permit fee without a permit. If no response within 5 business days of date on letter by certified mail notification. 1% times the assessed value of improvement will be added.

\*\*\*All Jefferson County Zoning fees are paid prior to action being taken or public hearing being conducted by the Zoning Administrator, P&Z Commission, Variance Board, and/or County Board of Commissioners. All fees are non-negotiable and non-refundable and will be paid at time of application unless stated otherwise.
