

Notice of Primary Election

Notice is hereby given that on Tuesday the 10th day of May, 2022 at the usual polling places in the election precincts of Jefferson County, Nebraska, an election will be held. The polls will open at 8:00 a.m. and close at 8:00 p.m. Said election will be for nominating candidates to various offices. Some races will not appear on the Primary Election as the number of candidates filing for office did not exceed twice the number of vacancies; these candidates are declared nominated and will advance to the November 8th, 2022 General Election, when candidates for (township officers, village boards, reclamation district boards, county weed district boards, public power district boards grossing under \$40 million and educational service unit board members) may be elected.
